DUES PROTECTION PROGRAM

POLICY: An Active Member may be granted a pro-rated refund of their Membership Dues under the following terms and conditions:

- 1) Truro Golf Club Membership Protection has been purchased.
- 2) Pro-rated Membership refund will only be considered for the following reasons:
 - a) Medical Condition with Doctor's certificate expressing the individual's inability to golf.
 - b) Relocation of Employment.
 - c) Board approved Extenuating Circumstances.
- **3)** Any application for pro-rated refund of Membership Dues must be submitted in written form to the Board for consideration and decision.
- **4)** Membership refund is pro-rated based on the following pre-determined Repayment Schedule, and is not determined based on when insurance is purchased.
- 5) Membership Dues without purchase of the Membership Dues Protection will only be considered by the Truro Golf Club Board on an individual basis, and if approved, the pro-rated Membership Dues balance will be carried forward to the following season (no cash to exchange hands).
